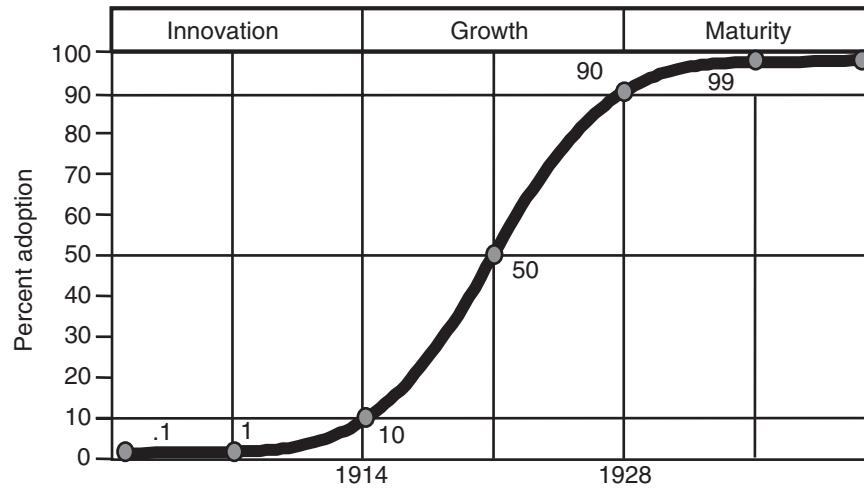

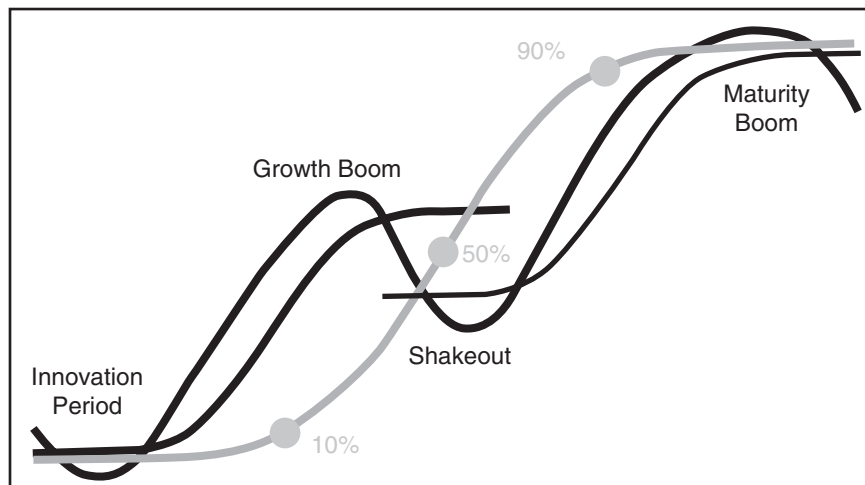

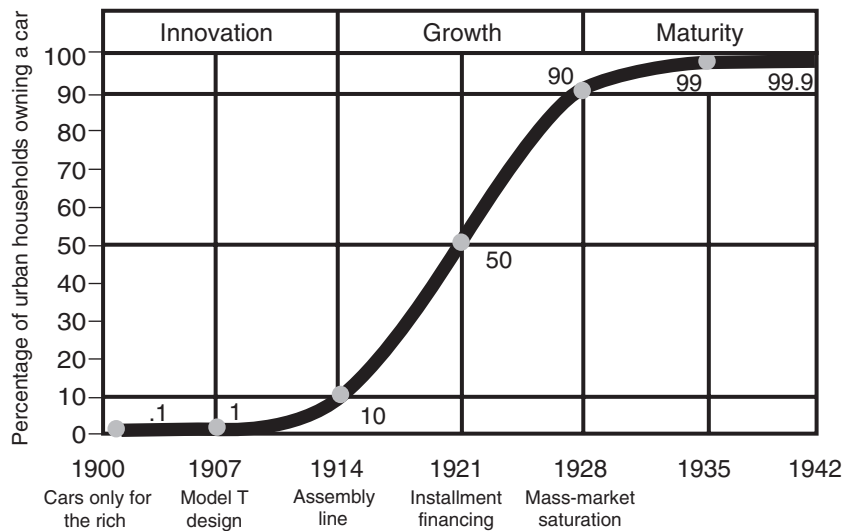
The S-Curve



Four-Stage Industry S-Curve Cycle

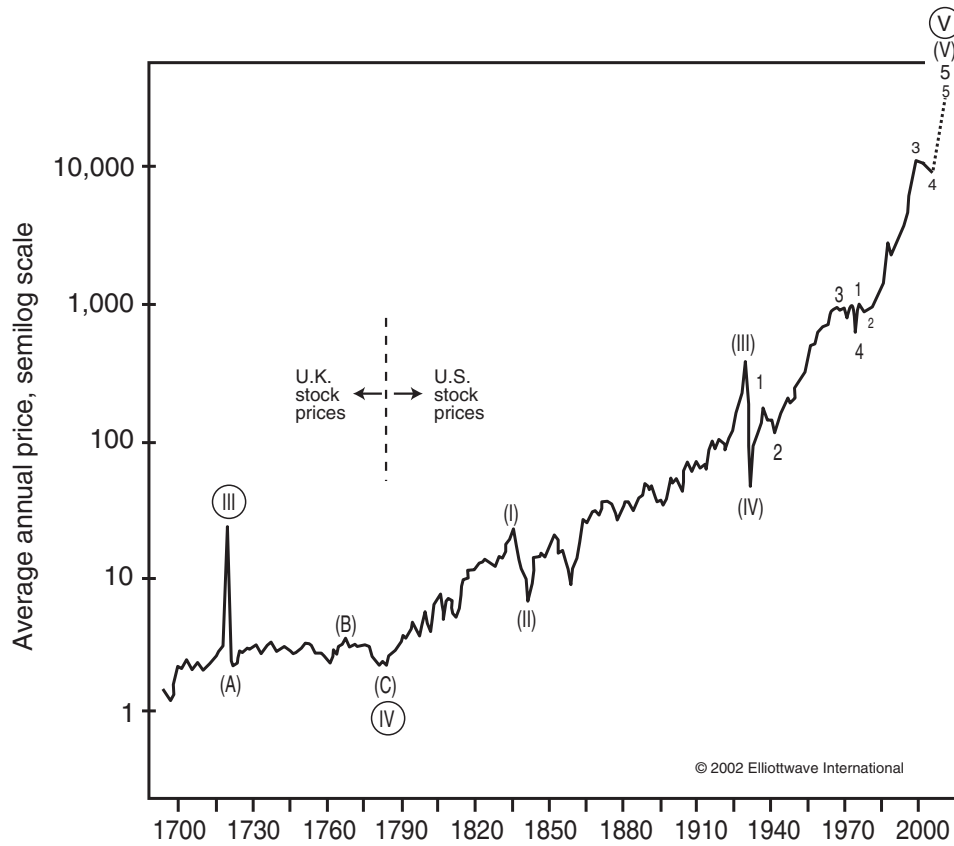


The Automobile S-Curve

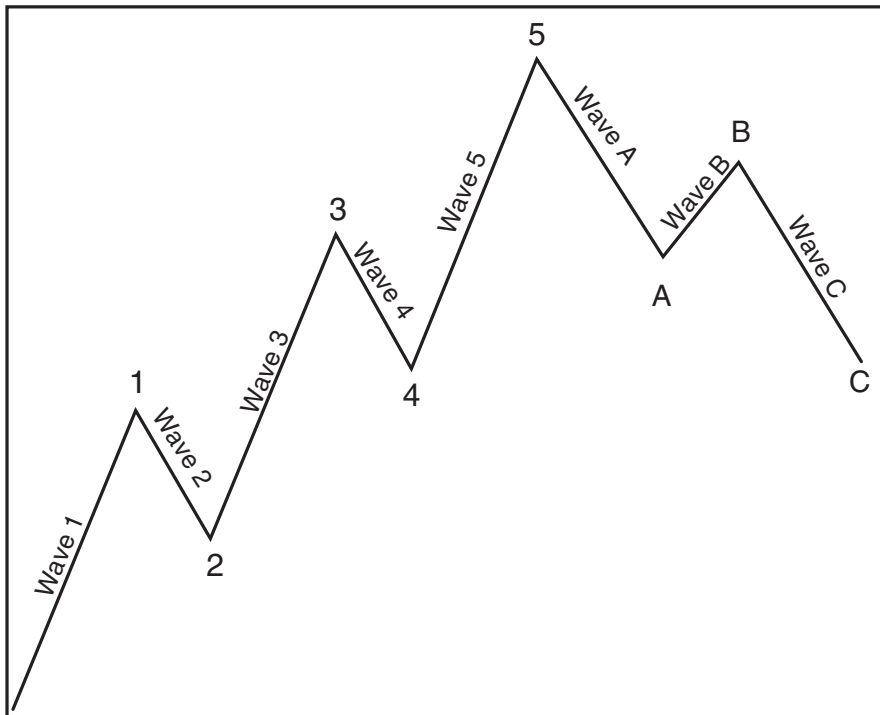
The Grand Supercycle: The Longer-Term Bull Market Since The 1780s

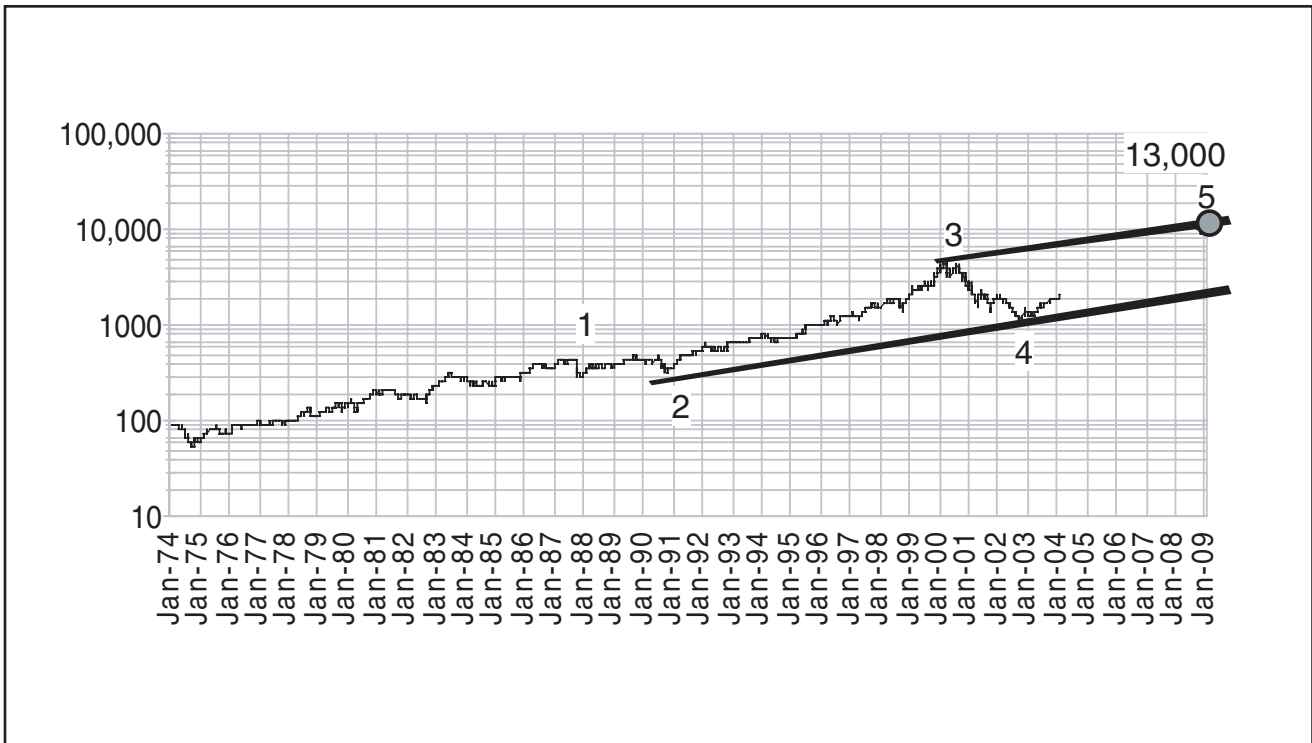

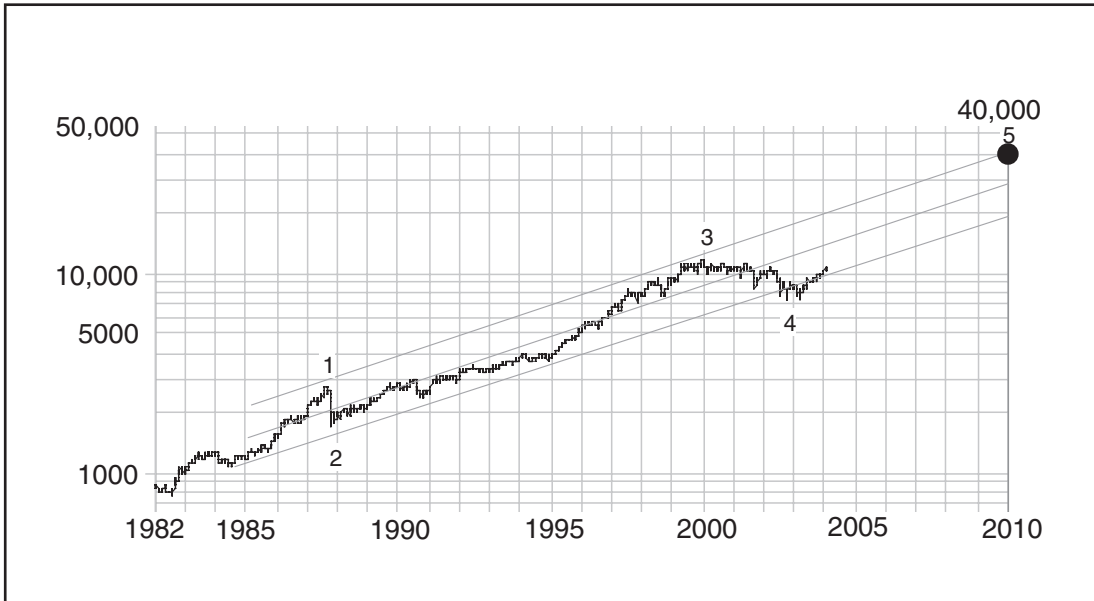

The Nasdaq Channel, 1974–2009

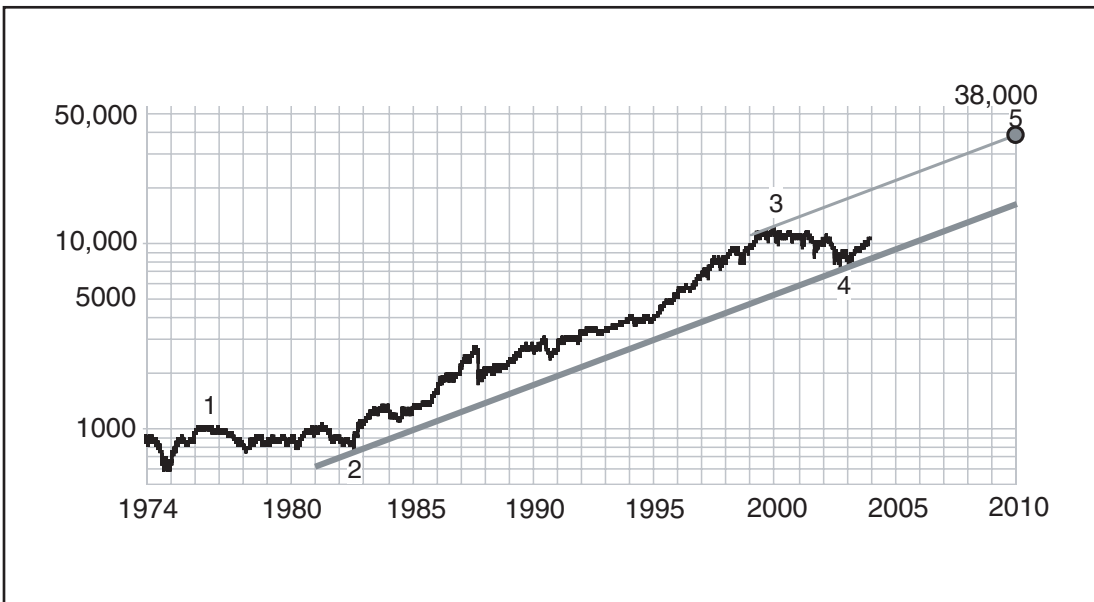

The Dow Channel, 1982–2010

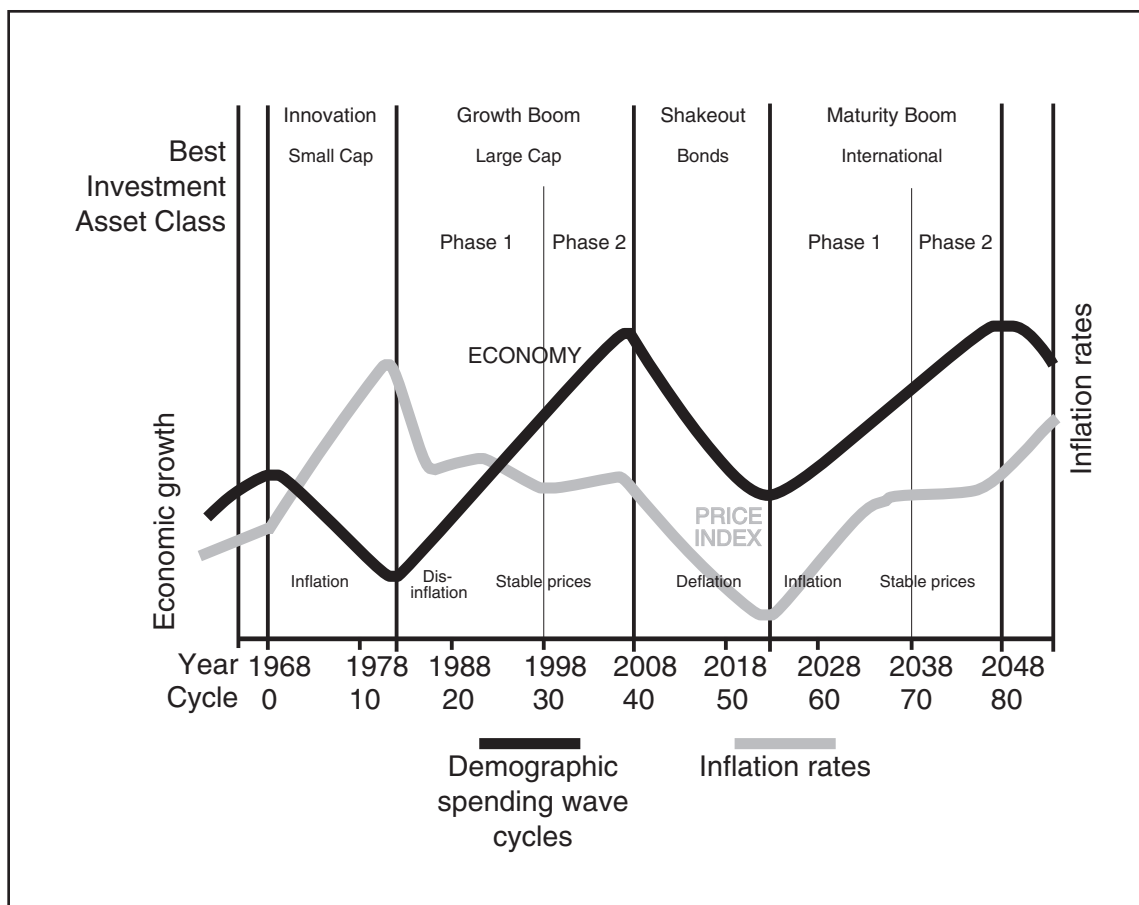


Revised Dow Channel, 1974–2010



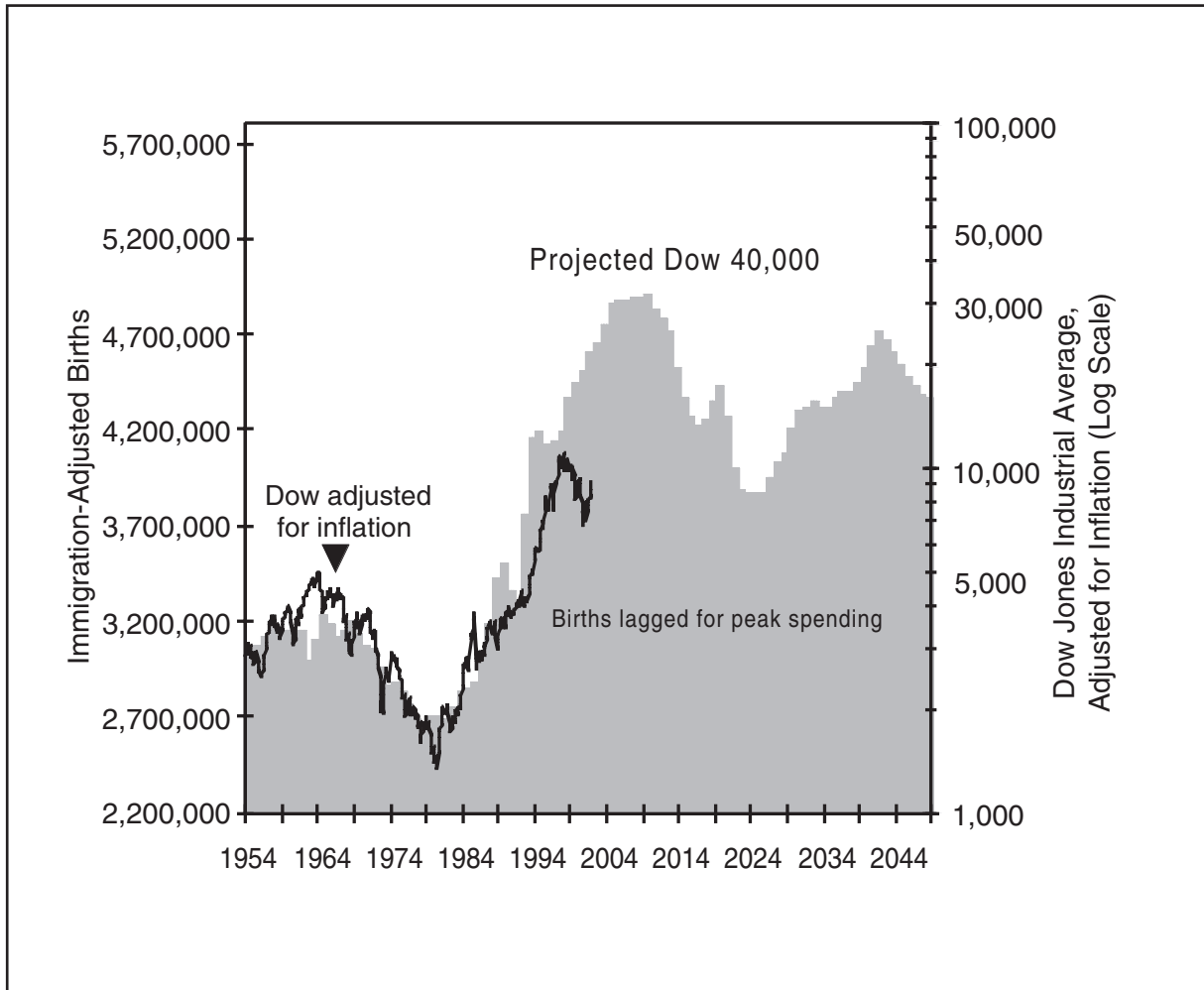

The Four Seasons of the Eighty-Year Economic Cycle



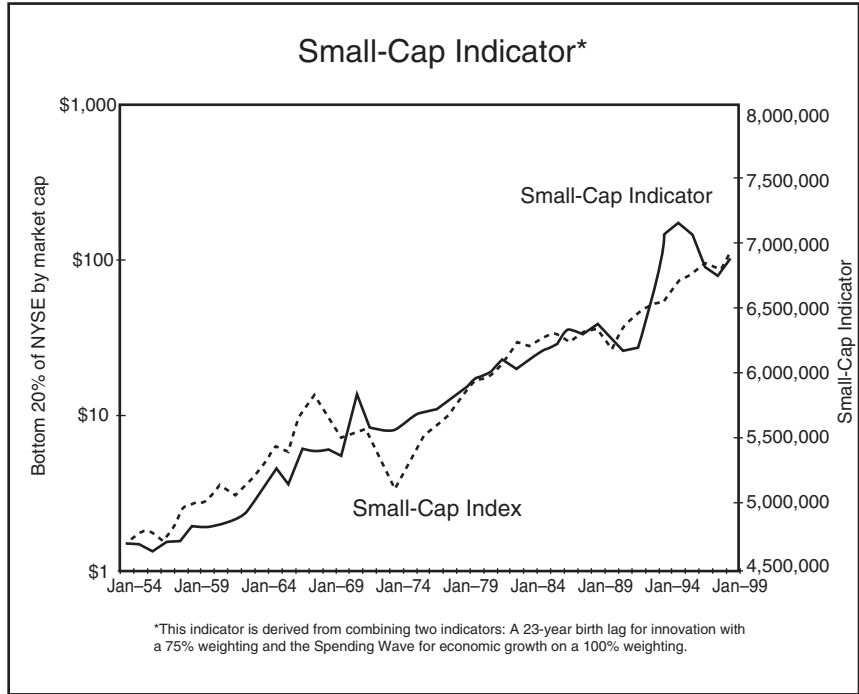

The Spending Wave: Births Lagged for Peak in Family Spending, 1956–2050

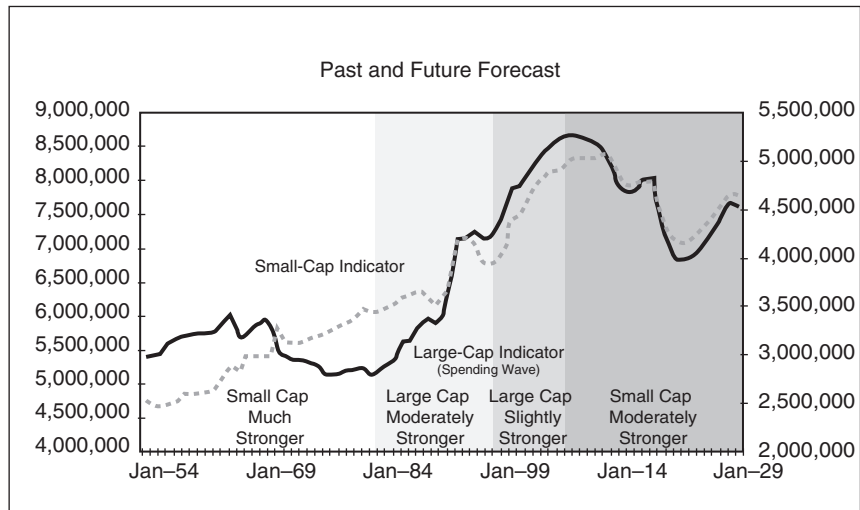

Small Cap Indicator, January 1954–January 1999

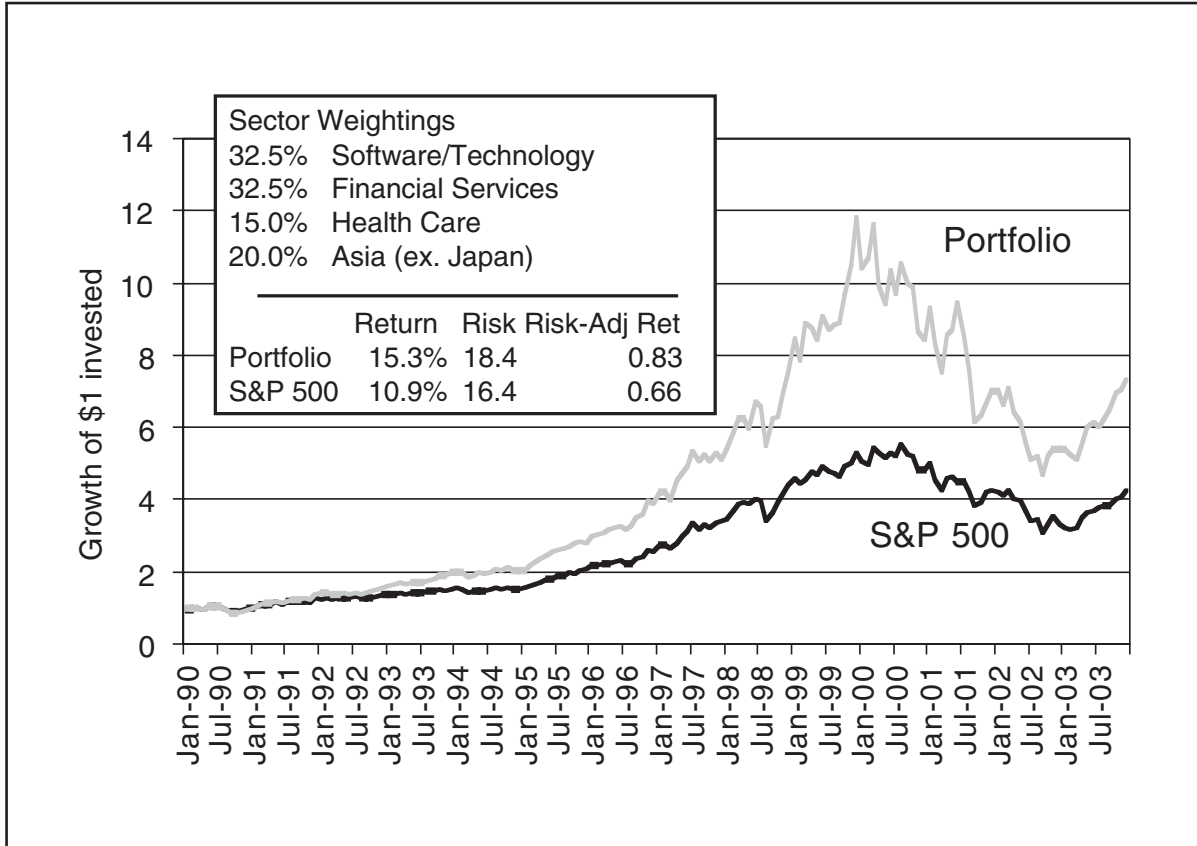


Large-Cap Indicator Versus Small-Cap Indicator, January 1954–January 2029

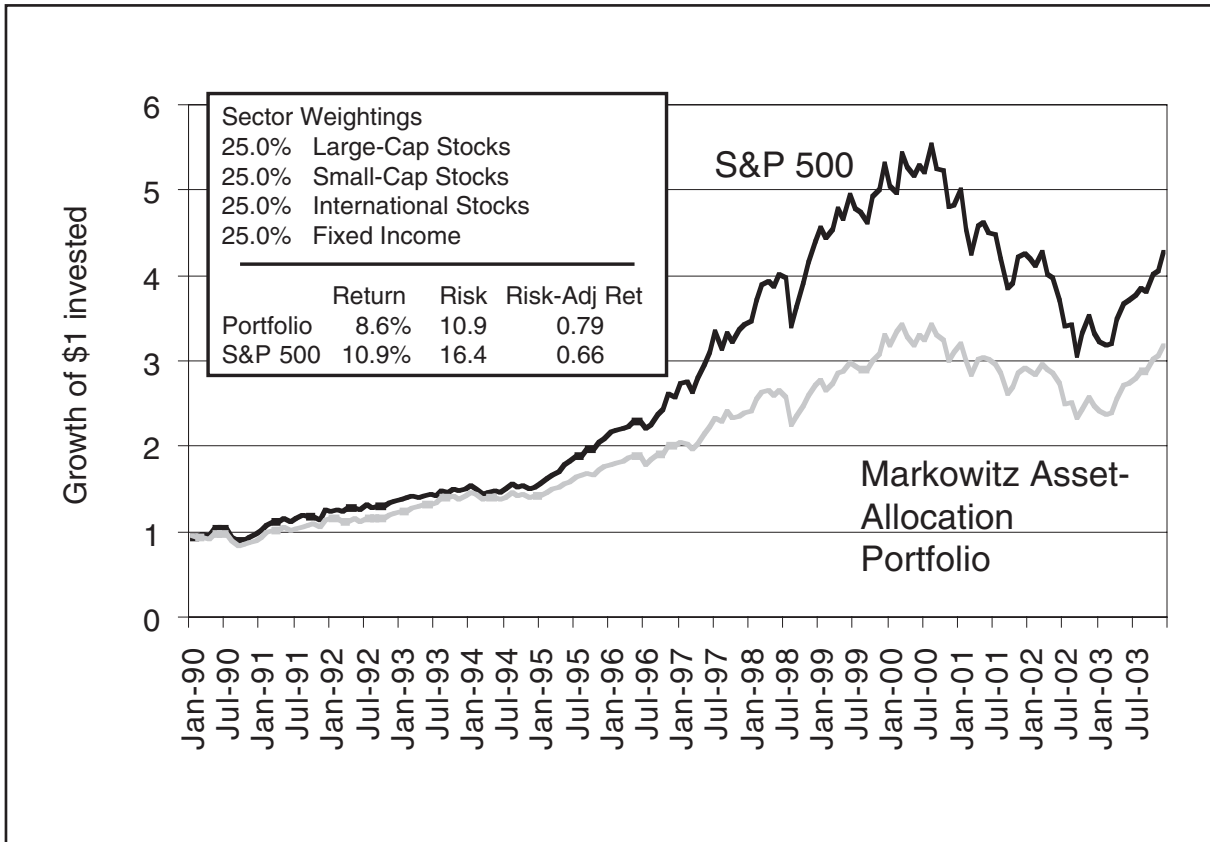

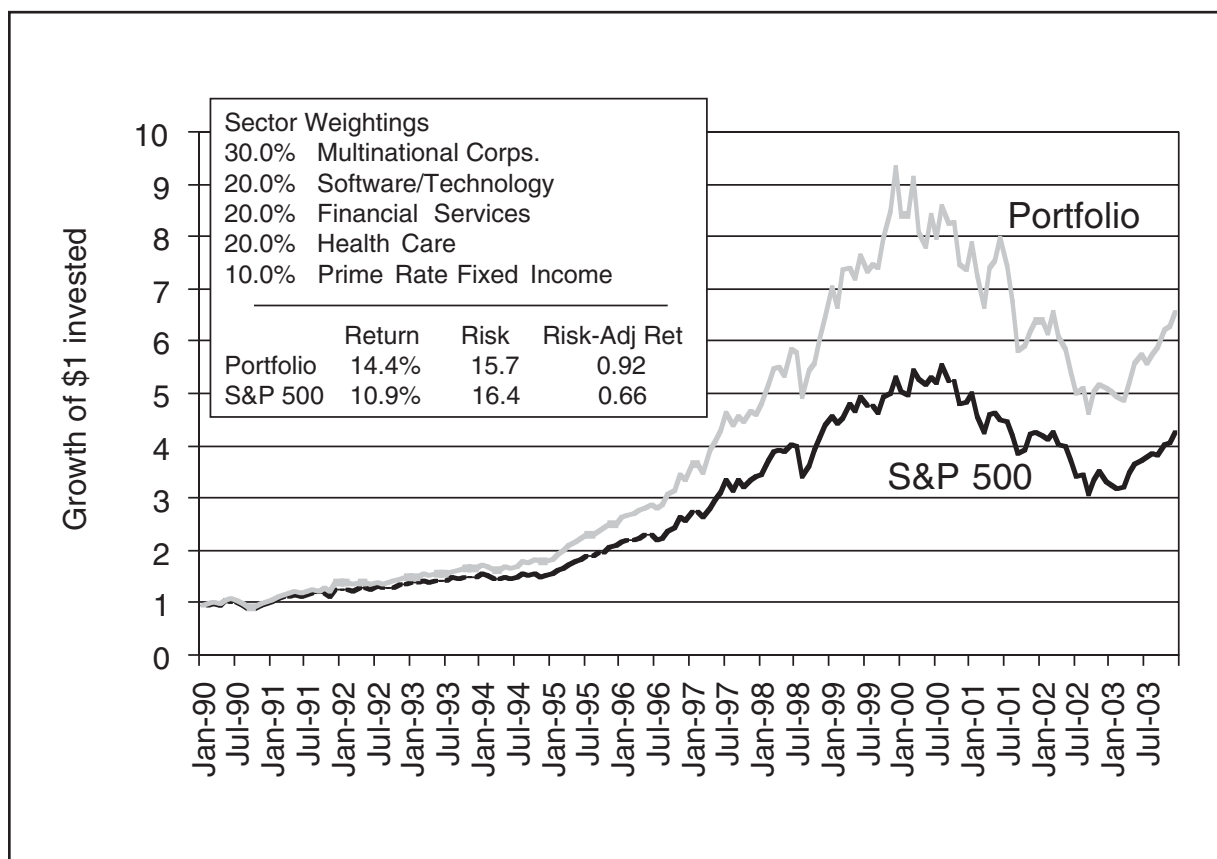
Aggressive Growth Portfolio, January 1990–December 2003

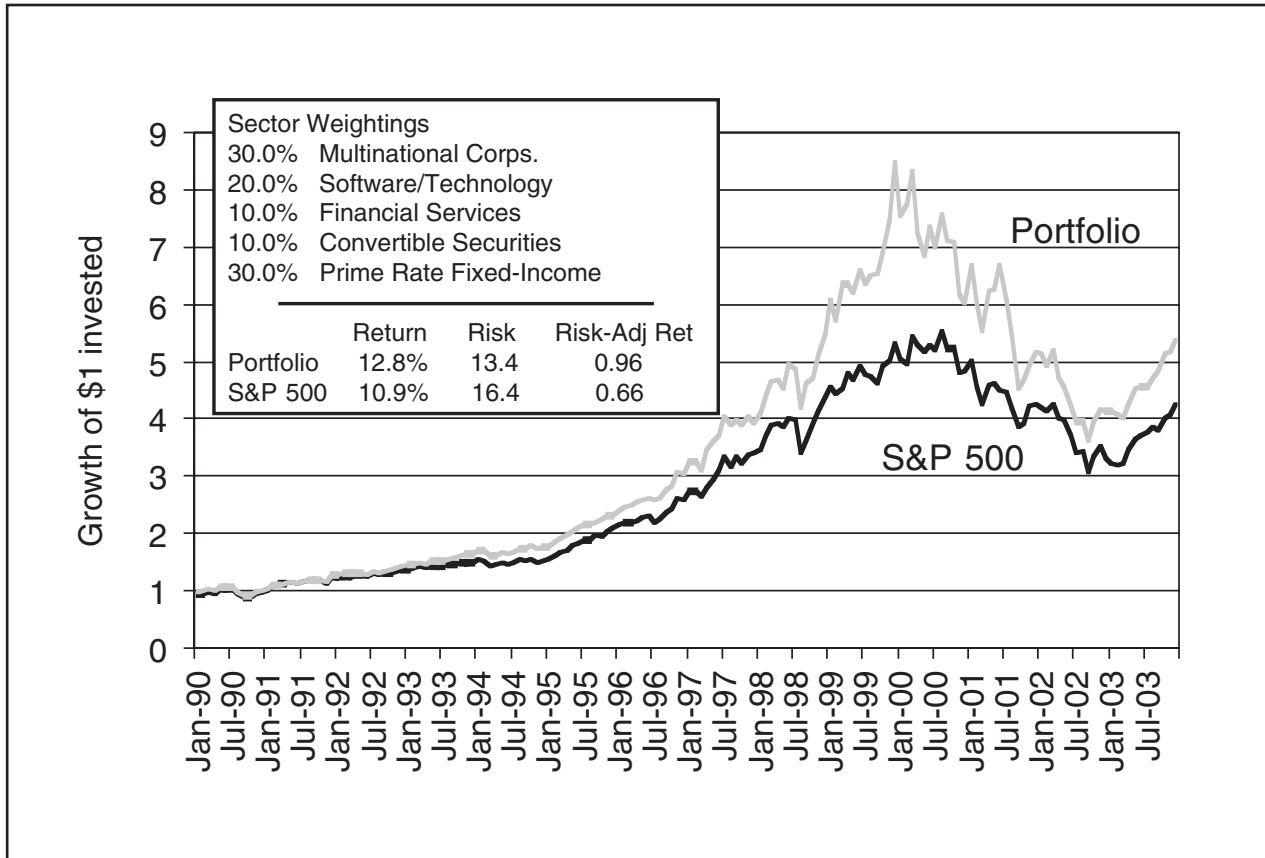


Growth Portfolio, January 1990–December 2003



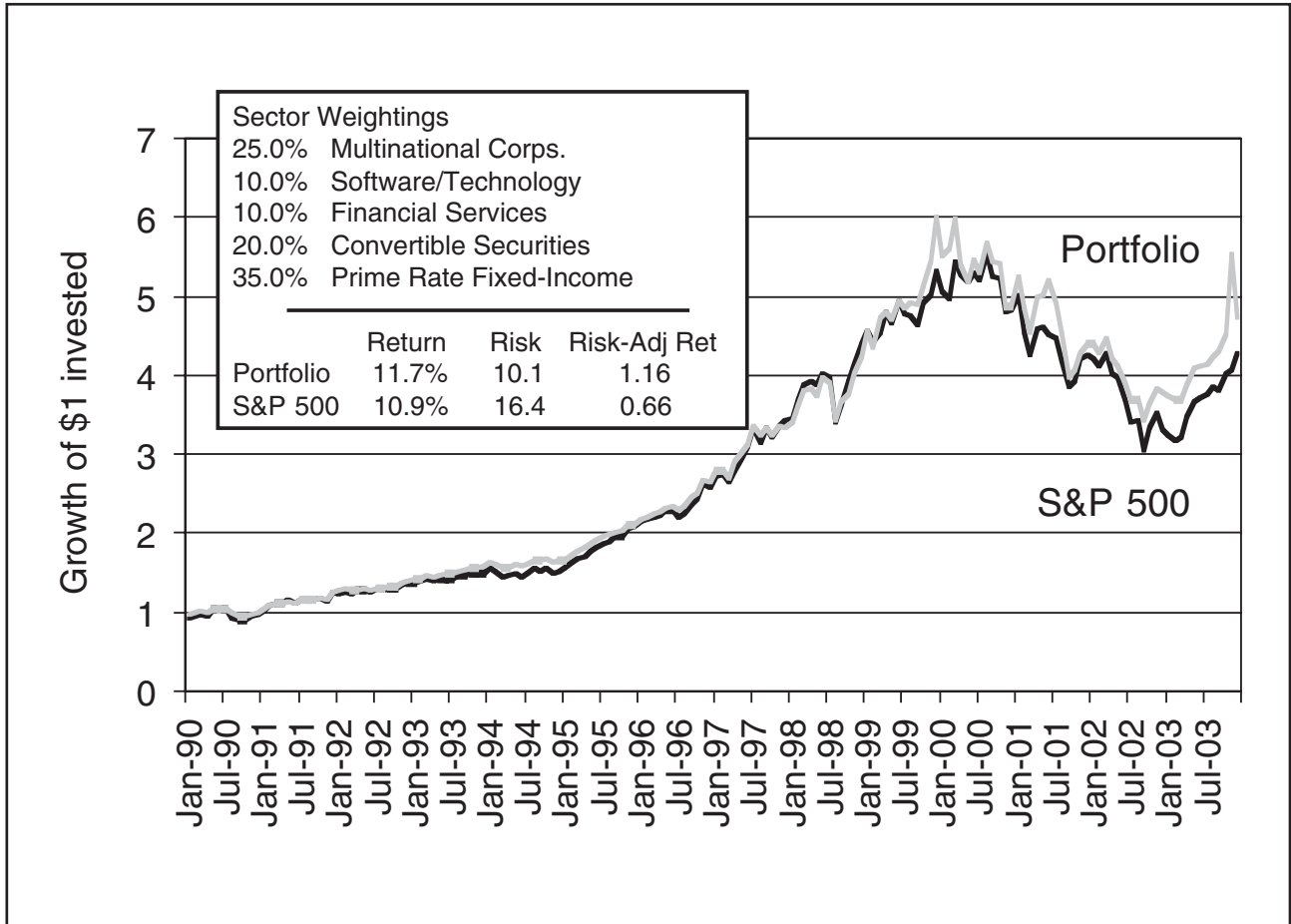

Growth and Income Portfolio, January 1990–December 2003



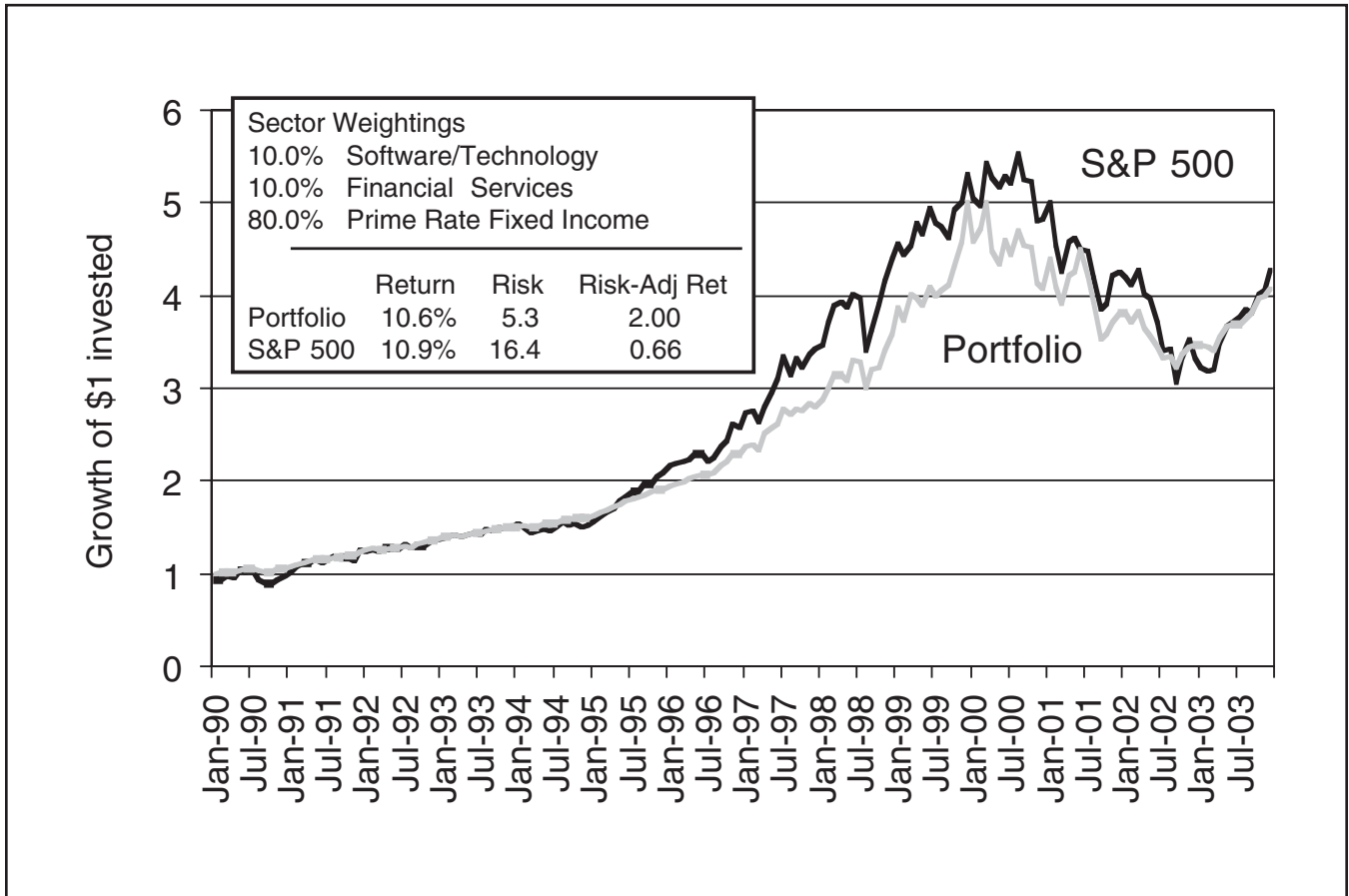

The Next Great Bubble Boom

AGGRESSIVE STRATEGY: PORTFOLIO ALLOCATIONS, 2010–2022

1. Late 2009 early 2010 to mid-2012: 90% Aaa corporate bonds, 10% T-bills, or CDs
2. Mid-2012 to late 2019: 25% health care, 25% biotech, 25% Asia, 15% newspapers/magazines and/or utilities, 10% Aaa corporate bonds
3. Early 2020 to late 2022: 90% Aaa corporate bonds, 10% T-bills, or CDs

GROWTH STRATEGY: PORTFOLIO ALLOCATIONS, 2010–2022

1. Late 2009 early 2010 to late 2014: 90% Aaa corporate bonds, 10% T-bills, or CDs
2. Late 2014 to late 2019: 30% health care, 15% biotech, 20% Asia, 20% newspapers/magazines and/or utilities, 20% Aaa corporate bonds
3. Early 2020 to late 2022: 90% Aaa corporate bonds, 10% T-Bills or CDs

CONSERVATIVE STRATEGY: PORTFOLIO ALLOCATIONS, 2010–2022

1. Late 2005 early 2010 to late 2022: 80% Aaa corporate bonds, 20% T-bills or CDs
